What is CCRNR?

The Canadian Council of Registered Nurse Regulators (CCRNR) serves as a national organization of the 12 regulators of registered nurses (RNs) across the country. CCRNR promotes the advancement of RN regulation in the public interest.

What does CCRNR do?

- We create and maintain a forum for the exchange of information on regulatory best practices, policies, and legislation at the Board of Directors level as well as within networks that represent key regulatory areas, e.g., communications, policy and practice, program review and approval, and registration.
- We monitor trends and issues across Canada and internationally.
- We advise on and promote promising regulatory practices and harmonized approaches to nursing regulation.
- We engage in projects of shared interest to members.
- We establish liaisons and partnerships that best position CCRNR and its members to address registered nurse regulatory matters.
- We promote an understanding of the purpose of nursing regulation and members' commitment to public safety and excellence in regulation.

PRIORITIES

CCRNR priorities' strategic direction: a unified approach to nursing regulation

NURSE PRACTITIONER REGULATORY FRAMEWORK IMPLEMENTATION PLAN PROJECT (NPR-FIPP)

CCRNR's NPR-FIPP is lead by Lynn Power and managed by CCRNR's Project Manager Jill Kovacs. Along with Lynn and Jill, and CCRNR's Communications Consultant Eugenia Afolabi, eleven jurisdictional volunteers and their alternates are the members of the Project's Steering Committee which meets regularly and drives the project forward, employing their expertise and commitment to the process.

NPR-FIPP launched in 2019 to coordinate a standardized approach to the regulation of nurse practitioners (NPs) in Canadian jurisdictions. Over the past year, the CCRNR Board agreed to recommend the approval of updated entry-level competencies (ELCs) for NPs by CCRNR member jurisdictions and initiated the NP practice analysis project. The benefits of using the work from the ELC process to inform the practice analysis, which will be key in the development of the new NP exam, is recognized and the efforts of CCRNR's volunteers in all these activities is sincerely appreciated.

CANADIAN NURSE REGULATORS COLLABORATIVE (CNRC)

The members of the three national groups of nurse regulators—CCRNR, the Canadian Council for Practical Registered Nurses (CCPNR) and the Registered Psychiatric Nurse Regulators of Canada (RPNRC), form the CNRC. CNRC meets regularly to facilitate collaboration, provide a forum for knowledge and information exchange, and to support collaboration on initiatives related to nursing regulation.

CNRC met twice in person over the last year in Toronto (November 2022 and May/ June 2023) and focused on priority items including the Language Proficiency Project, governance/terms of reference, multi-jurisdictional registration, and Nursys Canada. CNRC also met with Health Canada's new Chief Nursing Officer, Dr. Leigh Chapman.

OTHER NOTABLE PROJECTS

Multi-Jurisdictional Registration

CCRNR continues to monitor activities related to multi-jurisdictional registration (MJR), options for RNs to practice in more than one jurisdiction within a single registration with one regulator. Reports were received during the year from those who are trying new and innovative methods of to allow for MJR in a variety of pilot projects across Canada.

Nursys in Canada/Unique Identifier

Nursys in Canada is a multi-year project of BCCNM and CNO with the support of the National Council of State Boards of Nursing (NCSBN) that will benefit the Canadian nurse regulatory system by allowing for the seamless sharing of registration information regulators. Also included will be the use of a unique identifier that can ultimately be beneficial in health human resource (HHR) planning. CCRNR extends its appreciation to the Canadian government for providing a grant for CNRC (applied for through CCPNR as a legal entity) to assist nurse regulators in preparation for the implementation of Nursys in Canada.

ONGOING AND NEW INITIATIVES

Collaborations, Consultations, and Meetings

Over the last year, CCRNR representatives met with Health Canada, both individually and as a participant in a number of consultations related to nursing and health human resources and Indigenous health and safety. CCRNR also continues its collaboration and interaction with the National Nursing Assessment Service (NNAS), the Canadian Nurses Association (CNA), the Canadian Association of Schools of Nursing (CASN), the Federation of Medical Regulatory Authorities of Canada (FMRAC) and the National Association of Pharmacy Regulatory Authorities (NAPRA), the National Council of State Boards of Nursing (NCSBN) and the International Council of Nurses (ICN) with many members attending the Congress in Montreal in July of 2023, and other stakeholders in nursing and health profession regulation.

The CCRNR was also able to benefit from presentations during the past year, two that focused on regulatory trends from both egal and governance perspectives: Julie Maciura of Steinecke Maciura LeBlanc and Deanna Williams of Dundee Consulting.
